VA.: 02) in Applied Arts, Painting, Textile Design, Plastic Art (Sculpture), Pottery-Ceramic and History of Visual Arts & Design for every candidate registered for Ph.D. in the Faculty of Visual Arts (In pursuance of Claus X of the Doctor of Philosophy/ Vidyavaridhi Ordinance, 2022-23).

COURSE CODE Ph.VA:01 & Ph.VA:02

- 1. The curriculum and duration of the Course Work in the Faculty of Visual Arts:
 - A) The curriculum of Course Work for the Ph.D. Degree shall be of Two Semesters
 - B) Each Semester shall extend to a **period of six months** from the date of admission of the candidate to the Ph.D. programme in the Faculty of Visual Arts.
 - C) A student of the Ph.D. degree programme shall not be permitted to seek admission concurrently to any other full time Degree or Diploma programme in the University.
 - D) A student is required to have full, ie. 100% attendance and condonation up to 30% can be considered for specific cogent reasons. Out of this 30%, only 10% condonation shall be permitted without taking any application from the student. Rest 20% condonation will be given by the Dean, Faculty of Visual Arts on prolonged illness. Student will be required to submit a certificate duly certified by the Medical Officer or the superintendent, S.S. Hospital, BHU or any other Registered Medical Practitioner.


