THE UNIVERSITY AT A GLANCE

Banaras Hindu University (BHU), stands as one of the most prestigious and historic educational institutions in the country. Founded in 1916 by the visionary nationalist leader Pandit Madan Mohan Malaviya, BHU was established with the mission of promoting Indian culture, spirituality, and values through modern scientific education. 



SECTION-2

COMMON UNIVERSITY ENTRANCE TEST (CUET) - 2025

Banaras Hindu University shall be taking admission to different programs/courses mentioned in this Bulletin based on the candidate's merit in CUET 2025 and other program/course-specific eligibility criteria mentioned in this bulletin. The CUET - 2025 will be conducted by the National Testing Agency (NTA) for which the candidate is advised to visit the official website of NTA - <https://cuet.nta.nic.in/> and <https://cuet.nta.nic.in/registration-for-cuetug-2025-is-live/>

General Instructions and Guidelines

2.1 Regular Students

- ✉ Applicants must be Indian citizens to be eligible for Undergraduate Program admissions at Banaras Hindu University.
- ✉ All candidates, including those applying under the supernumerary quota, must appear for the Common University Entrance Test (CUET-UG) 2025. Registration for CUET-UG 2025 is available at www.nta.ac.in.
- ✉ For seat allocation and admissions, candidates are required to apply through the Common Allotment Program (CAP-UG 2025) of Banaras Hindu University.

2.2 Foreign Nationals

- ✉ 15% of supernumerary seats in each program are reserved for foreign nationals.
- ✉ Candidates under the Foreign Students category must register through the Foreign Students' Registry only.
- ✉ Foreign National Candidates, including those who have completed their previous qualifying degree from an Indian university or board, will be considered foreign candidates for admission purposes. Such candidates will be eligible for admission under the quota designated for foreign students.
- ✉ Foreign candidates seeking admission to postgraduate programs must apply through the **Foreign Students' Registration Portal** at <https://bhu.ac.in>.
- ✉ Foreign nationals are exempted from appearing in the CUET (UG) - 2025.
- ✉ Admissions under the foreign students' category will be merit-based only.

- ✉ Admissions to all undergraduate programs at BHU and its 'colleges admitted to the privilege of BHU' will be determined by scores obtained in the Common University Entrance Test (CUET-UG) 2025.
- ✉ Seat allocation and admissions for all undergraduate programs (excluding Foreign Students) will be conducted through the Combined Allotment Program – Undergraduate 2025 (CAP-UG 2025). Detailed information regarding CAP-UG 2025 will be announced on the official BHU admission website at <https://bhu.ac.in>. Candidates must frequently check this website for updates.

2. Pre-Registration Guidance

- ✉ Before registering for CUET-UG 2025, candidates are strongly advised to carefully read the CUET-UG Information Bulletin 2025 issued by BHU.
- ✉ Candidates should also familiarize themselves with the Banaras Hindu University Act, 1916, the University Statutes (including amendments), and the Ordinances, Rules, and Regulations available on the BHU website.

3. Eligibility Criteria

- ✉ Candidates must ensure they meet the **Minimum Eligibility Criteria** before applying.

- ✎ Students appearing for their qualifying degree examination or awaiting results are eligible to appear for CUET-UG 2025 but must fulfill eligibility requirements at the time of admission.

4. Program-Specific Requirements

- ✎ Candidates must meet the program-specific eligibility criteria and appear for the relevant CUET paper. Details about the syllabus are available at www.nta.ac.in.
- ✎ Admission is based solely on CUET-UG 2025 scores, except for programs requiring practical test or physical test.

5. Admission Responsibility

- ✎ Candidates must verify their eligibility for their chosen program(s) before appearing for CUET-UG 2025. Admission will only be granted if all prescribed eligibility criteria are met.
- ✎ Misrepresentation of eligibility, category, or other claims will result in admission cancellation and may lead to legal action.

6. Admission Process

- ✎ In addition to CUET-UG 2025, candidates must apply for BHU's Combined Allotment Program – 2025 (CAP-UG 2025).
- ✎ Certain fields (e.g., name, signature, photograph, registered email and mobile number) will auto-populate from the CUET-UG 2025 form and cannot be edited in the CAP-UG 2025 application.

7. Reservation Policies

- ✎ Candidates seeking reservations under SC/ST/OBC-NCL/EWS/PwBD/SPORTS categories must upload valid certificates during the CAP-UG 2025 application.
- ✎ Candidate and parent names must match those on qualifying certificates and CUET-UG 2025 records.

8. Additional Notes

- ✎ Gap years will not affect eligibility for admission.
- ✎ There is minimum age requirement for each program. Candidates are required to ensure it before applying.
- ✎ Pursuing two regular degree programs simultaneously is not permitted.

9. Regular Updates and Notifications

- ✎ Candidates must regularly check the BHU admission website (<https://bhu.ac.in>) for updates and notifications. Grievances arising from unawareness of published information will not be considered.

The implementation will give the students a lot of flexibility in their choice of Major + Minor courses and shall also offer them vast opportunities to choose from:

1. Multidisciplinary Courses (MD)
2. Skill Enhancement Courses (SEC)
3. Ability Enhancement Courses (AEC) and
4. Value-Added Courses (VAC).

1. The candidates at the time of registration shall be required to give their preference for the 'Major' and 'Minor' course only. Other courses (MD, SEC, AEC and VAC) will be allotted later. The 'Major Subjects' allocated to candidates will not change with Minors at any level.
2. Banaras Hindu University (BHU) offers a four-year UG program under NEP curriculum for both Honors and Research, namely UG Honors and UG Honors with Research. Only 10% of students with a CGPA of 7.5 and above will be permitted to select UG Honors with Research based on merit.
3. All UG courses under NEP curriculum will be Eight Semesters (Four Years) Course with exit options as per NEP norms.
4. As per the UGC Guidelines, December 2022 on NEP-2020, the total Credit of UG program should be minimum of 160, (20 Credits in each Semester). Accordingly, the Credit distribution for UG (Hons.) and UG (Hons with Research) may be as per the following:

10. All the UG students will require to pursue 9 credits of Skill Enhancement Courses from any of the following broad disciplines:
 - a. Information Technology Skill
 - b. Communication Skill
 - c. Life Skill
 - d. Account & Finance Management Skills
 - ✦ There are several courses in each discipline which should be chosen by the candidate
 - ✦ Candidate will have option to choose Skill Enhancement Courses. Every department has designed & developed suitable SECs.
11. All the UG students will have to pursue 8 credits of Ability Enhancement Courses, related to Modern Indian Languages (MIL) and English Language. The students having "Language" as Major are not allowed to opt the same language course as Ability Enhancement Course.
12. All the UG students will have to pursue Value Added Courses with total of 8 credits from any of the following broad disciplines. These courses are of 1, 2, 3 or 4 credits depending on course content.

2.6 MINIMUM ELIGIBILITY REQUIREMENTS

1. Restrictions on Reappearing in the Entrance Test

- Candidates already admitted as regular students in Semester-I of any course through an entrance test in previous year, and who are eligible to appear for the 2nd-semester examination, are not permitted to re-appear for the entrance test for the same course.
- Candidates' ineligible for the 2nd-semester examination due to insufficient attendance or failure to submit the examination form on time may be allowed to reappear for the entrance test provided they meet the eligibility criteria.
- Candidates already admitted to Semester-III beyond are not allowed to take the entrance test for the same course. Violations of this rule by bonafide students will be treated as misconduct and dealt with accordingly.

2. Qualifying Examination Requirements

- Candidate must have passed the Class XII examination or its equivalent from a recognized board.
- Alternatively, candidates must have passed the Class XII examination from any Board/University in India, or a foreign institution recognized as equivalent to the 10+2 system by the Association of Indian Universities (AIU).
- For admission to the Banaras Hindu University, candidates are required to appear in the CUET (UG) - 2025 in the subjects they have studied and/or passed in Class XII.
- If grades are awarded in the qualifying examination:
 - ↻ Where the grade sheet does not indicate the equivalent percentage, candidate must submit a certificate from the institution specifying the percentage or the formula for conversion.
 - ↻ If the grade sheet includes the percentage or conversion formula, candidate must provide photocopies of both sides of the degree/grade sheet.
- The aggregate percentage of marks includes grace marks, as reflected in the final mark sheet. For courses with different types of final mark sheets (e.g., BHU's B.A./B.Sc. Hons.), the aggregate will be calculated using the total marks for all subjects studied over all the years, rather than just honors subjects.

3. Recognition of Degrees/Certificates

- Only degrees/certificates recognized by the **Association of Indian Universities (AIU)** are considered equivalent.
- For distance education, recognition by the **Distance Education Council of IGNOU/AIU** is required. Such candidates must submit recognition/approval certificates from the IGNOU Distance Education Council.

4. Eligibility Requirements and Information Bulletin

- The eligibility criteria specified in the Information Bulletin and CAP-UG for the academic session are final.

5. Rejection of Fraudulent Applications

- Applications with forged or fraudulent certificates will be rejected, and the candidate may be barred from future entrance tests.
- Admission may be cancelled if the candidate fails to meet eligibility requirements, provides false documentation, or suppresses information.

6. Test Appearance

- Candidates must appear in the entrance test. Admission is subject to verification of qualifying mark sheets, certificates, and the absence of misconduct in previous examinations.
- Appearance in the test or achieving passing marks does not guarantee admission. Applicants must meet all eligibility criteria before submitting their application.

2.7 RESERVATION, RELAXATION & SUPERNUMERARY QUOTA

The reservations to different categories of candidates are as per the Government of India Rules and the decision of Academic and Executive Council. Reservation is available as per the following description:

2.7.1 Scheduled Caste/Scheduled Tribe

- Seats shall be reserved for Scheduled Caste (15%) and Scheduled Tribe (7.5%) candidates in each Course. Admission against these seats will be made provided the candidate has passed the Qualifying Examination and appeared in the Central University Combined Entrance Test conducted by NTA.
- Every SC/ST candidate shall have to submit a self-attested copy of the Caste Certificate mentioning that the candidate belongs to SC/ST community. The Caste/ Tribe of the candidate must be listed in the appropriate Govt. of India schedule. Such certificates shall be subject to verification from the concerned District Magistrate. The following are empowered to issue the certificate. Certificate from any other person/authority shall not be accepted in any case.
 - District Magistrate/Additional District Magistrate/Collector/Deputy Commissioner/Addl. Deputy Commissioner/ Deputy Collector/1st Class Stipendiary Magistrate/ City Magistrate/Sub-Divisional Magistrate/Taluka Magistrate/ Executive Magistrate/Extra Assistant Commissioner.
 - Chief Presidency Magistrate/Addl. Chief Presidency Magistrate/Presidency Magistrate.
 - Revenue Officer not below the rank of Tehsildar.
 - Sub-Divisional Officer of the area where the candidate and/or his family normally resides.
 - Administrator/Secretary to the Administrator/ Development Officer (Lakshadweep Islands).
 - The Caste Certificate should clearly state: (a) Name of his/her caste/tribe (b) whether he/she belongs to SC or ST (c) District and the State or Union Territory of his/her usual place of residence and (d) the appropriate Govt. of India schedule under which his/her caste/tribe is approved by it as SC or ST.
 - In case a SC/ST candidate seeks admission under some other category (for example, PwBD/Employee Ward etc.) the candidate should satisfy the minimum eligibility requirement for that category.

2.7.2 Other Backward Class (OBC)

- 27% reservation to candidates belonging to OBC category (excluding under creamy layer) will be provided in different courses. The authorities to issue the OBC certificate are the same as in case of SC/ST.
- To be eligible for admission under OBC quota, the caste of the candidate must be listed under OBC Category of the list of Central Govt. Further the OBC certificate should clearly mention that the candidate is not under creamy layer.
- If an OBC candidate seeks admission under some other category (for example: PwBD/Employee Ward etc.) the candidate should satisfy the minimum eligibility requirement for that category.

2.7.3 Economically Weaker Sections (EWS)

In accordance with O.M.F.No.12-4/2019-U1 dated 17th January 2019 of the Department of Higher Education, MHRD, Government of India, 10% reservation for Economically Weaker Sections shall be provided in admission during the Academic Session 2025-26.

- The EWSs certificate duly issued by the competent authority with regard to fulfilment of the following criteria as per Government of India norms of the prospective candidate(s) claiming admission under this category for admission to various UG courses:

The persons who are not covered under the scheme of reservation for SC, ST and OBC and whose family has gross annual income below Rs. 8.00 lakh (Rupees eight lakh only) are to be identified as EWS for the benefit of reservation. Income shall also include income from all sources, i.e., salary, agriculture, business, profession, etc. for the financial year prior to the year of application. Also persons whose family owns or possesses any of the following assets shall be excluded from being identified as EWS, irrespective of the family income:

- 5 acres of agricultural land and above;
- Residential flat of 1000 sq. ft. and above;
- Residential plot of 100 sq. yards and above in notified municipalities;
- Residential plot of 200 sq. yards and above in areas other than the notified municipalities.

2.7.4 Persons with Benchmark Disability (PwBD) {minimum 40% disability}

- 5% seats shall be reserved for Persons with Benchmark Disability Candidates:
- Blindness and low vision; (1%) + (b) deaf and hard of hearing; (1%) + (c) loco-motor disability including cerebral palsy, leprosy cured, dwarfism, acid attack victims and muscular dystrophy; (1%) + (d) autism, intellectual disability, specific learning disability and mental illness; (1%) + (e) multiple disabilities from amongst persons under clauses (a) to (d) including deaf-blindness in the seats identified for each disabilities: (1%).
- The PwBD candidates called for Counselling for possible provisional admission will be examined by a Medical Board constituted by BHU and if necessary, will be referred by the Medical Board to other recognized bodies for the purpose, as per criteria fixed by the University. The decision of the Medical Board constituted by BHU will be final.

Note: Wherever the number of seats is small, the University will have the right to combine some of the groups to calculate the number of seats for reserved categories.

2.7.5 Consideration of Reserved Category Meritorious Candidates as General Candidates

- In a course, if the merit of a reserved category candidate is more than or equal to the merit of the last admitted general candidate in that course, the reserved category candidate will be treated as general candidate in that course. Provided further that if a meritorious reserved category candidate is admitted by relaxing the general qualifying standards (minimum eligibility requirement and/or age) or is admitted to a higher preferred course (allotment of Honours subject, Major Minor combination, Specialization, if any) which he/she would not have got by remaining under the general category, then his/her admission shall be adjusted against the concerned reserved category quota and the consequential vacancy created in the general category shall be filled up by a general category candidate in order of merit.

2.7.6 Relaxation in Minimum Eligibility Criteria for Scheduled Castes (SC), Scheduled Tribes (ST), Other Backward Classes (OBC) and Persons with Benchmark Disability (PwBD)

- In the case of SC/ST candidates, there will be no requirement for minimum percentage of marks in the aggregate in the qualifying examination except that they must have passed the qualifying examination & appeared in the concerned Common University Entrance Test conducted by NTA.
- The SC/ST candidates seeking admission to **B.A. LL.B.** must have scored at least 40% marks in the aggregate considering all the subjects in the Qualifying Examination as per recommendations of Bar Council of India.
- For OBC and PwBD candidates there will be a relaxation of 5% marks in aggregate in the qualifying examination in minimum eligibility requirements, in comparison to general category candidates.

2.7.7 Relaxation in upper age limit for persons with benchmark disability (PwBD)/SC/ST/OBC

- There is an age relaxation of 5 years in upper age limit for candidates belonging to SC/ST and PWD categories and 3 years in upper age limit for candidates belonging to OBC category for admissions in various courses wherever the upper age limit is prescribed.

2.8 SUPERNUMERARY SEATS (BHU EMPLOYEE WARD, PAID, ICAR, SPORT AND FOREIGN NATIONAL)

Candidates seeking admission on a supernumerary seat under any of the following supernumerary quota shall be required to meet the eligibility conditions as are prescribed for general category candidates for the

concerned course except Sports seats where minimum eligibility will be as per described in the section of Sports seats.

2.8.1 BHU EMPLOYEE WARD SEATS

- 15% supernumerary seats in all the courses (including special courses) shall be available for the sons/daughters (including married daughters) of (i) permanent employees (including those on probation) of BHU currently in service or were so during the academic Session immediately preceding the Session for which the Common University Entrance Test of UG conducted by NTA (ii) Contractual employees/Daily Wager/Out Sourcing Employees of the University who have been in four years of continuous service from the last date of registration for admission.
- In order to be considered under the quota the applicant must fulfil the minimum eligibility requirements and must submit a claim in the registration form for UG Admissions that he/she belongs to employee ward category and qualifies in the CUET-UG.
- The regular employee ward applicant is required to upload a certificate issued by the Dy. Registrar (Administration)/Downloaded from ERP certified by Head at the time of registration. For Contractual/Daily Wager/Out Sourced Employees the certificate issued by their concerned DDO.
- Similarly, 15% of the supernumerary seats in colleges admitted to the privileges of the University shall be reserved for the daughters of permanent employees of girls' colleges, and for the sons and daughters of permanent employees at DAV Post Graduate College, either currently in service or during the academic session immediately preceding the session for which the entrance test is held.
- Further, wherever the provision of employee ward quota for admission in a course of the University exists, the provision of granting benefit of Employee Ward will be extended to the following two groups of serving and retired/deceased employees also by creating one supernumerary seat (for each group) in addition to the seats available for the employee wards provided the merit index of the wards of the said two groups in the merit of entrance test conducted for admission in the course is not below the last admitted candidate under employee ward quota in that course:
 - (i) Employees joining the University on deputation; &
 - (ii) Wards of the deceased employees and re-engaged/retired BHU employees subject to the condition that the privilege will be available upto the academic year succeeding the year in which the deceased employee would have attained/retired employee attains the age of 65 years.

2.8.2 ICAR SEATS

15% supernumerary seats shall be available for admission for Candidates nominated by the ICAR on the basis of Combined Admission Test conducted by the ICAR for B.Sc. (Hons.) Ag. Admission.

2.8.3 PAID SEATS

There is provision for supernumerary paid seat (not exceeding 15% of the total number of seats) in regular courses. However, no such provision is available for Special Courses. Reservation policy will be applicable under paid seats category as per the Government of India Rules.

2.8.4 SPORTS SEATS

Supernumerary Seats in various Faculties/Institute shall be available under sports category as per details given below:

2. No such provision is available for Special Courses Except B.A. LL.B. under the Faculty of Law.

- ☞ Candidates shall be considered for Sport Seats only on approval from the University Sports Board.
- ☞ In order to be eligible in sport quota seats: (a) A candidate should have passed the qualifying examination; (b) should have appeared in Common University Entrance Test of UG conducted by NTA of concerned course; (c) must fulfil the AIU participation rules; (d) should have participated and secured position in the National/Inter-Zonal National Championship or should have secured a position in Zonal/Inter Zonal/Direct All India Inter University Tournament/championship of AIU games.
- ☞ The candidate, thus, found eligible for admission under sports seats shall have to qualify practical test i.e., modified AAPHER youth fitness test of 40 marks and playing ability test of 60 marks in the concerned games/ sports event. However, candidates from the following sports/games – Archery, Chess and Shooting will be exempted from Modified AAPHER youth fitness test of 40 marks. The candidate must secure at least 50% marks in Modified AAPHER youth fitness test (not applicable for Archery, Chess and Shooting) and playing ability. The practical test will be conducted by a committee constituted by University Sport Board in consultation with Controller of Examinations.
- ☞ The merit of the qualified candidates for the admission in Sports Seats shall be decided by the Sport achievement marks awarded on the basis of certificates of achievements. Highest Sport achievement marks/performance of a candidate will only be considered while counting the sports achievement marks.

- 1) Inter District National Championship will not be allowed.
- 2) Sports Performance of Last three Years will be entertained only.
- 3) In case of equal sports achievements points of candidates in a faculty, the inter-se ranking will be decided on the basis of the CUET Merit and If CUET Merit is also equal then the aggregate percentage of marks in the qualifying examination will be considered. If these are also equal then the candidate senior in age will be preferred.
- 4) The candidate who has represented India or Indian (combined) University team in world Universities games will get direct admission provided he/she has passed the qualifying examination and applied for admission in the course before the last date of submission of application form.
- 5) The following games/sports certificates will not be considered as these games are either not approved by the AIU or the University does not have sufficient infrastructure:[Ball Badminton (M/W), Base Ball (M/W) Canoeing and Kayaking (M/W), Cycling (M/W), Fencing (M/W), Korfball (M/W), Rowing (M/W), Softball (M/W), Yachting (M/W), Tenicot (M/W), Carrom (M/W), Circle Kabaddi (M/W) and Gatka (M/W)].
- 6) It is mandatory for the Sports Quota admitted students to report for the sports practice during practice session of the game/event.
- 7) Admission may be cancelled in the case of not attending sports practice for the team going to participate in competitions.

2.8.5 FOREIGN NATIONALS

- 1) Provision to the extent of 15% supernumerary seats for Foreign Nationals exist, out of which 5% seats will be filled up by children of NRIs [Persons of Indian Origin (PIO)] and 5% by children of Indian workers in Gulf and South Asian Countries.
- 2) In case applications are not received and/or seats remain vacant in any of these sub-categories, those vacant seats could be pooled and allotted to remaining sub-categories. The details about this may be obtained from the Office of the International Centre, C/3/3, Tagore House, Banaras Hindu University, Varanasi-221 005. (visit our BHU website: www.bhu.ac.in).
- 3) The minimum eligibility criteria shall be securing 50% marks in aggregate in the qualifying examination. The nomenclature and pattern (10+2) of qualifying degree/certificate may vary from country to country.

In case of doubt in the minimum eligibility criteria shall be decided by the respective admission committee of the faculties/departments/centers through the International Center.

2.9 INTER-SE RANKING - Breaking Ties in CUET (UG) - 2025 Merit Scores

In case of a tie, where two or more candidates have the same CUET(UG)-2025 merit score for a Program + Faculty/College Combination, the tie-breaking rules will be applied in the following sequence:

- 1) Preference shall be given to the candidates who have a higher aggregate percentage of marks at the Qualifying Examination.
- 2) However, in cases for admission to B.Sc. and B.Sc. (Hons.) Ag., the aggregate marks in Science subjects shall only be considered for this purpose.
- 3) Even, if case tie, then Preference will be given to candidates with higher aggregate percentages in the best three/four/five Class XII subjects.
- 4) In case the candidates have equal marks in the above-stated Examinations, then the candidate senior in age shall be given preference.

INSTITUTE OF MEDICAL SCIENCES



The Institute of Medical Sciences (IMS), a distinguished constituent of Banaras Hindu University, stands as a premier medical institution in India, notable for its four comprehensive faculties: the Faculty of Medicine, comprising 35 departments; the Faculty of Ayurveda, with 17 departments; the Faculty of Dental Sciences; and the College of Nursing. In addition to these faculties, the Institute operates several constituent hospitals, offering a total of 2,614 beds, including 1,385 in Sir Sunderlal Hospital, 180 in the Ayurveda Wing, 334 in the Trauma Centre, 13 in the Faculty of Dental Sciences, 430 in the Centenary Super Specialty Block, 100 in the Mother & Child Health Wing, 60 in the Centre of Excellence for Mental Health, 12 in the Bone Marrow Transplant & Stem Cell Research Centre, and 100 in the Regional Institute of Ophthalmology. IMS also houses a Regional Resource Centre for Telemedicine, providing state-of-the-art tele-education and tele-consultation facilities with high-tech classrooms.

The Institute offers comprehensive academic programs in medicine, including undergraduate (UG), postgraduate (PG), post-doctoral (D.M. and M.Ch.), and Ph.D. degrees, fostering cutting-edge research, clinical training, and medical practice in a wide array of disciplines.

Hospitals and Clinical Facilities

With 1,385 beds in Sir Sunderlal Hospital and 334 beds in the Trauma Centre, IMS extends world-class healthcare services to economically disadvantaged populations from Eastern Uttar Pradesh, eight neighbouring states, and even the adjoining country of Nepal. In addition to these facilities, IMS maintains a Staff Health Centre and a Student Health Care Complex, ensuring quality medical services for the staff and students of the University.

IMS is currently undergoing a major transformation, aspiring to become an institution of excellence akin to the All-India Institute of Medical Sciences (AIIMS). As part of this upgrade, a 430-bed Centenary Super-Specialty Block has been established, offering highly advanced and specialized medical care. This state-of-the-art facility is equipped with 13 modular operating theatres, 50 Intensive Care Units (ICUs), and 19 Critical Care Units (CCUs), covering 11 major super-specialty disciplines. The block also features a modern blood bank with component separation facilities, which has received an 'A' grade rating from NACO, New Delhi. A mobile blood bank van further enhances patient care services.

Additionally, several new healthcare facilities have been inaugurated, including a 100-bed Mother and Child Health Wing, a 100-bed Regional Institute of Ophthalmology, a 12-bed Bone Marrow Transplant & Stem Cell Research Centre, and a 60-bed Centre of Excellence for Mental Health. These units, inaugurated by Honourable Prime Minister Shri Narendra Modi, are now fully operational.

Trauma Centre

The Trauma Centre of IMS is the largest of its kind in India, housing 334 beds, including a 27-bed modern ICU. The facility is centrally air-conditioned and equipped with centralized gas and vacuum distribution, supported by a 10,000-liter liquid oxygen plant. The centre features 13 modular operating theatres, as well as extensive outpatient (Orthopaedics, Plastic Surgery, Neurosurgery) and inpatient (Neurosurgery, Orthopaedics, Plastic Surgery, Polytrauma, and Emergency) services. It operates 24-hour emergency services, staffed with Advanced Trauma Life Support (ATLS) and Advanced Cardiovascular Life Support (ACLS) trained personnel and equipped with advanced resuscitation tools. Furthermore, the Trauma Centre offers round-the-clock imaging services, including a 128-slice CT scanner, a 1.5 Tesla MRI machine, ultrasonography (USG), and X-ray facilities. The Centre also boasts a blood bank, a 225-seat auditorium for academic activities, and 24-hour ambulance services, ensuring comprehensive care for trauma patients.

The Faculty of Sanskrit Vidya Dharm Vigyan, established in 1918, was founded with the dual purpose of preserving and advancing the study of ancient Indian scriptures, Sanskrit language, and literature, while fostering a meaningful dialogue between Eastern and Western traditions. Initially known as the Faculty of Prachya Vidya, one of its primary aims is to challenge and dispel unfounded misconceptions surrounding Hindu religion, spirituality, astrology, and Tantra. It is equally dedicated to restoring the fundamental values of morality and religion, contributing to the upliftment of society at large and particularly focusing on the well-being of the masses. The Faculty preserves traditional methods of instruction, with classical texts being taught in alignment with India's rich oral and written traditions.

Currently, the Faculty encompasses eight departments and one centre, offering study in 23 subjects. It provides courses at the Shastri (Undergraduate) and Acharya (Postgraduate) levels across eight disciplines, alongside Vidyavaridhi (Ph.D.) program in Sanskrit, Theology, and traditional subjects. Additionally, it offers several diploma and certificate courses.

The Faculty publishes an annual research journal, Sanskritvidya, which serves as a platform for scholars of Oriental sciences. Furthermore, it has consistently published the Vishwapanchang since 1926 CE, continuing a legacy of scholarly contribution.

A Shashtri in Shukla Yajurveda and Krishna Yajurveda gains deep knowledge of Vedic rituals, yajnas, and spiritual philosophy. Expertise in Vyakaran (grammar) and Sahitya (literature) enhances linguistic precision and scriptural interpretation. Jyotish Ganit and Jyotish Falit provide insights into mathematical astrology and predictive sciences. Sankhyayoga and Nyay-Vaisheshika develop logical reasoning and metaphysical understanding, while Vedant explores ultimate reality. Puranetihas and Dharmashastra offer historical and ethical perspectives. Mimansa and Dharmagam refine ritualistic analysis. Comparative studies in Jain Darshan and Bauddha Darshan enrich philosophical discourse. This knowledge benefits scholars, priests, astrologers, and philosophers in spiritual and academic pursuits.

Passed Madhyama Examination of BHU/Madhyama/Uttar Madhyama/Upa Shastri/Intermediate or 10+2 or equivalent with a minimum 50% marks in the aggregate. Sanskrit must be one of the subjects in the concerned examination and candidate should have passed in this subject also.

The candidates having passed one year certificate course in Sanskrit of BHU after passing 10+2 examination with 50% marks in aggregate both in 10+2 examination and certificate examination are also eligible.
