The CENTRAL HINDU BOYS SSS BHU KAMACHHA VARANASI UP is affiliated with the Board with affiliation number 2130037. As per conditions of affiliation, the school was to abide by the provisions of rules and regulations given by the board time to time.

All affiliated schools vide Board's notification dated 18.10.2018 had been informed to abide by the rules laid down in Examinations and Affiliation Bye-Laws. As per Rule 12.1 of Affiliation Bye-Laws, if a School is found violating the provisions of the Affiliation Bye Laws/Examinations Bye Laws of the Board or does not abide by the directions of the Board, the Board shall have powers to impose the penalties under rule 12 which also includes withdrawal of Affiliation.

In this connection, on analysis of your result data, oasis data and registration data following discrepancies have been observed in Class X / XII data:

- STUDENT TEACHER RATIO IN HINDI COURSE-A, MATHEMATICS, SCIENCE, SOCIAL SCIENCE, ENGLISH COMM. NOT FOUND AS PER NORMS in class 10
- 2 STUDENT TEACHER RATIO IN MATHEMATICS, PHYSICS, CHEMISTRY, PHYSICAL EDUCATION, ACCOUNTANCY, ENGLISH CORE, HINDI CORE NOT AS PER NORMS in class 12
- IN CERTAIN CASES OF SUBJECTS HINDI COURSE-A URDU COURSE-A MATHEMATICS SCIENCE SOCIAL SCIENCE ENGLISH COMM. PRACTICAL MARKS/INTERNAL MARKS ARE NOT IN RIGHT PROPORTION WITH THEORY MARKS IN CLASS 10.
- 4 IN CERTAIN CASES OF SUBJECTS HISTORY, GEOGRAPHY, ECONOMICS, PSYCHOLOGY, PHYSICS, CHEMISTRY, BIOLOGY, PHYSICAL EDUCATION, BUSINESS STUDIES, ACCOUNTANCY, AGRICULTURE, COMPUTER SCIENCE, HINDI CORE, , PRACTICAL MIARKS ARE NOT IN RIGHT PROPORTION WITH THEORY MARKS IN CLAS

Therefore, the school is hereby alerted and directed to abide by the rules of Affiliation & Examination Bye-Laws of the Board in true letter and spirit. Besides, the school is required to oversome the deficiencies pointed out above and submit compliance before commencing the academic session 2020-2021 in April.
