NOTICE

Based on the result of B.Pharm (Ay.)/BOT/BPT Entrance Test-2021 held on 19.12.2021 for the admission to B. Pharm (Ay.)/BOT/BPT course, the following applicants have been provisionally selected under the category mentioned against their names.

Accordingly, the aforesaid applicants are requested to appear before the Admission Committee of the Institute on **11.02.2022** in the office of the Director, Institute of Medical Sciences, Banaras Hindu University, Varanasi for counselling for which they are required to **report at 10:00AM on aforesaid date at New Lecture Complex, IMS, BHU.**

The aforesaid provisionally selected applicants are required to deposit the requisite fee and submit following **original documents** alongwith two photocopies of each:

- High School or its equivalent, which shall be retained by the Institute.
 - Intermediate (10+2) or its equivalent, which shall be retained by the Institute.
 - Six copies of passport size photograph which is same as the one uploaded in the application form.
 - Character certificate issued from the Institution last attended.
 - Transfer/Migration certificate from the Institution/University/Board last attended.
 - Provisional Admit Card of B. Pharm (Ay.)/BOT/BPT Entrance Test-2021.
 - Valid category certificate issued by the Competent Authority/Centre i.e. PH/EWS/SC/ST/OBC (Non-Creamy Layer Certificate Central Govt.) etc.
- Inter-se-rank will be decided at the time of counselling after verifying the original documents as per Information Brochure.
 - (a) The selected applicants are advised to bring them approximately Rs. 15,000/- to cover the regular fee at the time of admission.

(b) The selected applicants are also required to deposite, Rs. 50,000/- in form of DD in favour of Registrar, BHU payable at Varanasi at the time of admission and thereafter each successive years towards special courses study fee till the duration of course.
 - The provisional admission is liable to be cancelled on any of the following ground(s):
 - If the applicants are found ineligible for the course at any point during the counselling.
 - Failure to produce all the prescribed documents in **ORIGINAL** at the time of admission.
 - Failure to deposit the the prescribed fees within the stipulated time.
 - The admission to the said course shall be cancelled at any stage of the B. Pharm (Ay.)/BOT/BPT course, if it is discovered that the applicant has submitted any fake/forged certificates/mark sheets/ photograph or any other relevant document or has concealed any material information.
 - Admitted students shall be governed by the Acts, Statutes, Ordinances, Rules & Regulations of the University as amended from time to time.

6. No request for extension in date of admission shall be entertained under any circumstances.
7. The date of commencement of B. Pharm (Ay.) course will be intimated later on.
8. No TA/DA shall be paid for appearing before the Admission Committee and joining the Course.
9. B. Pharm (Ay.) course will be conducted/ run at **Rajiv Gandhi South Campurs, Barkachha, Mirzapur**, applicants are advised to come prepared accordingly since during the course of study they are required to stay in the hostel at RGSC only.
10. The admission process may go on for two days hence, the selected applicants are requested to come prepared and make their own arrangement for stay at Varanasi.
11. Hostal facility is not available for BOT/BPT courses.
