Applications in the prescribed format are invited from the eligible Assistant Professors/Associate Professor of the University satisfying eligibility conditions laid down in the **University Grants Commission (Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and other Measures for the Maintenance of Standards in Higher Education) Regulations, 2018** for consideration of **promotion under Career Advancement Scheme (CAS)** as per the stages as mentioned in UGC Regulations.

The teaching staff of the University who consider themselves eligible for promotion under CAS as per aforesaid UGC Regulations are required to submit their application with duly filled in the prescribed proforma (enclosed as **Annexure-A**) along with reprints (**one set**) with the relevant documents, for consideration for promotion under CAS to the respective HoDs/Deans/Director /Coordinators/Principal/Faculties/Institutes/Centres/Schools.

The Directors of the Institutes/Deans of the Faculties/Principal of Mahila Mahavidyalaya/Heads of the Departments/Coordinators of the Schools/ Centres etc. are requested to circulate the Notification amongst the Assistant Professors/Associate Professor (including those who are on leave) and forward their applications in the prescribed format duly checked and verified about the correctness of the entries recorded therein.

The cases for promotion under Career Advancement Scheme shall be regulated as per the guidelines of the UGC contained in the **University Grants Commission (Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and other Measures for the Maintenance of Standards in Higher Education) Regulations, 2018**. The applicants may visit these regulations as available on UGC website: www.ugc.ac.in and on BHU website: www.bhu.ac.in/rac.

Those who have applied earlier need not apply again. However, they may update their application.

The application completed in all respect with required relevant documents shall be submitted to the **Recruitment & Assessment Cell, Holkar House, BHU, latest by 07th Jan., 2020.**


